An Ordinance creating a special improvement project entitled “Emma Yule Park”, Fund 354, Program 064, to accumulate all costs for the improvement project.

WHEREAS,

- A. The City of Everett is committed to a planned parks capital improvement program as part of the City of Everett Parks & Community Services Comprehensive Plan.
- B. The City of Everett is requesting funding approval for the utilization of Capital Improvement Program - 3 (CIP-3) to construct a park in the Glacier View Neighborhood at 4817 Rucker Avenue in the City Parks system;
- C. The City of Everett and the YMCA of Snohomish County have entered into an agreement for the conveyance to the City of approximately 1 acre of land located at 4817 Rucker Avenue and for the purpose of constructing and maintaining a neighborhood park;

NOW, THEREFORE, THE CITY OF EVERETT DOES ORDAIN:

Section 1. A special improvement project is hereby established as Fund 354, Program 064, and shall be entitled “Emma Yule Park” to accumulate all costs for the improvement project.

Section 2. Authorization is hereby given to accumulate costs and distribute payments from Fund 354, Program 064 for the improvement project.

Section 3. Authorization is hereby granted to the Parks and Facilities Director, under direction of the Mayor, to assume full and complete responsibility for conducting all tasks and doing all things to accomplish the action authorized in this ordinance.

Section 4. The sum of \$2,050,000.00 is hereby appropriated to Fund 354, Program 064, “Emma Yule Park” as follows:
