



## EXHIBIT B

### Biosolids Temporary Staging Plan

#### 1. Overview

- A. King County is proposing to unload, temporarily stage, reload and haul out dewatered biosolids on the biosolids pad at the City of Everett's property commonly known as the Water Pollution Control Facility, 4027 4<sup>th</sup> Street SE, Everett WA.  
  
A legal description of the property is included as Exhibit A.
- B. The source of the biosolids is any of King County's wastewater treatment plants. The biosolids will meet all Federal and State regulations for a Class B biosolids as defined in 40 CFR part 503 and WAC 173-308. Biosolids should be at least 20% total solids.
- C. King County will utilize a dump truck and trailer combination to deliver the biosolids to the biosolids pad for temporary storage. King County will then load truck and trailer units to transport the biosolids to their existing end-use sites for beneficial reuse.
- D. Trucks and trailers will be cleaned of all biosolids that may adhere to their vehicles during loading and unloading operations before leaving the biosolids pad. It shall be King County's responsibility to promptly clean up any biosolids that are deposited on any roadways entering or leaving the biosolids pad as a result of their activities.
- E. King County is responsible for contacting the Snohomish County Public Works Department or other applicable agency regarding any haul routes to verify constraints or restrictions that might apply and complying with all applicable regulations.
- F. King County will provide all equipment and personnel necessary to perform this task in a safe, reliable and legally compliant manner.
- G. King County is required to coordinate all their activities with the City's Biosolids Program Manager or other City Staff as designated by the Biosolids Program Manager for activities on the biosolids pad. The City will make all reasonable efforts to minimize interference from other construction activities.
- H. King County must obtain approval from the Department of Ecology Biosolids Coordinator for the Northwest Region for this project prior to project initiation.

#### 2. Temporary Staging Area Site

- A. An area approximately 60 feet by 200 feet has been designated as the temporary staging area. It is outlined on three sides with ecology blocks, two blocks high
